

ADOPTED AMENDMENT TO THE BY-LAWS OF MERIDIAN ON SAND KEY OWNER'S ASSOCIATION, INC.

The following is an adopted amendment to the By-Laws of Meridian on Sand Key Owner's Association, Inc., recorded in Official Records Book 10907, Pages 2657 et seq., within the Public Records of Pinellas County, Florida, and as subsequently amended.

NOTE: New wording is <u>underlined</u>, deleted wording is <u>stricken through</u>, and *** indicates omitted text.

Section 2.4 of the By-Laws of Meridian on Sand Key Owner's Association, Inc., is hereby deleted in its entirety and replaced with the following (substantial rewording of provision; please see Section 2.4 for current text):

2.4 Voting. The members of the Association are entitled to one (1) vote for each unit owned by them. The total number of votes ("voting interests") is equal to the total number of units. The vote of a unit is not divisible. If a unit is owned by one natural person, individually or as trustee, the right to vote shall be established by the record title to the unit. If a unit is owned jointly by two or more persons, that unit's vote may be cast by any of the owners provided only one vote shall be cast. If multiple owners attempt to cast votes which are in conflict with those cast by another owner, the vote for that unit will not be counted.
